Sarah Slamer of The National Institute for Trauma and Loss in Children This presentation provides insight from adolescents diagnosed with autism spectrum disorder who also experience trauma. Learn what these adolescents tell us about trauma, private logic and what is driving challenging behaviors, including struggles with social situations, bullying and anxiety. Strategies will be given to help empower and alleviate trauma symptoms. Testifying in Court • \$25

Courts rely on information provided by these professionals to assist with decisions rendered by the court. Sarah Slamer of The National Institute for Trauma and Loss in Children This workshop will discuss the need for prevention and early intervention with infants and children from birth to 5 years of age. Trauma's impact on the brain and a comparison of stressed versus secure attachment as well as the importance of parent/caregiver involvement will be highlighted. Developmentally specific trauma intervention strategies designed to decrease child hyper-arousal and other post trauma symptomology while increasing parent/caregiver attachment will be shared. Stewards of Children • FREE!
